Terms and Conditions

- 1. The bid should be submitted in a sealed cover superscribed as "Tender for Auction of **Diplomatic Car**" and addressed to "Consulate General of India, Birgunj". The last date of submission of bids is **27.10.2025 (1600 hrs)**.
- 2. The sealed envelope submitted by the bidder must contain:
- a) General Information of the bidder along with the bid price in Nepali Rupees, clearly written in both figures and words (format given at Annexure-II). The bid must be valid for at least 120 days from the last date of submission.
- b) Earnest Money Deposit (EMD) in the form of cheque/Demand Draft for NR 62995/(NRs Sixty Two Thousand Nine Hundred and Ninety Five Only) in favour of
 Consulate General of India, Birgunj.
- 3. The bid will be confirmed in favour of the person quoting the highest rate in respect of the vehicle.
